The Foundation distributes support from over 115 different scholarship funds. This year, awards ranged from \$500 up to full tuition and fees.

Education criteria vary, as well, and most scholarships target graduating seniors, while some are available to students currently enrolled in college.







Additionally, a "Snoddy's" Coal Creek Cemetery Endowment Fund has been established for those wishing to include the cemetery in estate planning or desiring to make larger gifts to help ensure the longterm viability of the cemetery.

Tax-Wise Tips For Year-End Giving

Year-end planning is a ritual for many of our friends who like to coordinate their tax and gift planning. However, it may take on additional significance as we adjust to the changing tax laws and marketplace. Individuals who want to make a difference for future generations should consider how they could increase the impact of their giving. Here are a few tax-wise tips that may be helpful for your year-end gift planning.

Gifts by Check or Credit Card. When you write a check to charity, the gift is complete when the check is mailed. Mail it by December 31, and you can deduct it for the year 2023 even if the charity does not cash it until 2024. When you charge your gift to a bank credit card, it is deductible by the donor in the year the charge is made.

Gifts of Stock. If your financial services provider holds the securities (including mutual funds) for your account, instruct that they be transferred electronically. We will provide you and/or your provider all the information needed. This is the most convenient way to make a gift. If you hold the stock certificate, give us a call and we can walk you through the transfer/donation process.

Gifts of Appreciated Property. Gifts of appreciated property that would result in long-term capital gain if sold generally produce even greater benefits for you than gifts made in cash, by check, or by credit card. The reason? You can generally deduct the full value of the contributed property (subject to the 30% of AGI limitation), even the gain portion that has never been taxed. Gift assets to consider include not only stocks, but bonds, mutual funds, real estate, and other appreciated property.

IRA Rollover Gifts. Legislation allows people age 70½ or older to withdraw up to \$100,000 annually from their individual retirement accounts tax-free if they give money directly to charity. Previously, withdrawals from individual retirement accounts were subject to income tax and early withdrawal penalties.

Year-end is indeed a special time to give. Through creative gift planning, you may very well be able to do more for yourself and for the causes that are important to you.
