# 2022

**NOVEMBER 15** – National Philanthropy Day<sup>®</sup> is both an official day and a grassroots movement. Every year since 1986, when President Ronald Reagan first proclaimed November 15th as National Philanthropy Day<sup>®</sup>, communities across the globe have celebrated by hosting events to recognize activities of donors, volunteers, foundations, leaders, corporations, and others engaged in philanthropy ("the love of humankind").

**NOVEMBER 29** – Giving Tuesday, often stylized as #GivingTuesday for purposes of hashtag activism, refers to the Tuesday after Thanksgiving in the United States. It is a movement to create a national day of giving at the beginning of the Christmas and holiday season. Giving Tuesday was started in 2012 as a response to commercialization and consumerism in the post-Thanksgiving season (Black Friday and Cyber Monday).

# FROM THE CEO'S DESK

#### What the Community Foundation Can Do For You

Nearly a decade ago, I recall being asked by one of our citizens, "*What can the community foundation do for me*?" After a brief moment, I responded the best I could, but our discussion eventually became quite lengthy. After visiting with this individual, I thought that there must be many more of our donors and citizens who might be thinking the same thing. So, below is my condensed version of our hour-long discussion.

The Foundation provides **permanence**. You are assured that your gifts will benefit the agencies, residents, and students of your community in

perpetuity ("forever"). Your gift will be safe. As a permanent endowment, the principal will never be spent – but the earnings will be there to permanently support your community.

The Foundation provides **flexibility**. You may select from a variety of types of funds, which we call "endowment funds." There are a variety of ways in which you may want to benefit your community with your gift. Check out all the options on our website at: www.wicf-inc.org.

Gifts to the Foundation can reduce your tax burden. Income taxes are reduced through deductions allowed by the IRS for contributions to a public charity, which is how a community foundation is classified.

Your community foundation provides **professional administration**. The community foundation continually assesses the changing needs of your community and awards grants to agencies best addressing those needs, sparing you, the donor, of having to make such judgments. In the case of designated funds, the community foundation easily handles the issuance of annual grants to the organizations you specify when you establish the fund.

Your community foundation provides a perfect alternative to a private foundation. Donors who want the individual involvement of a private foundation without the accompanying administrative complexities, restrictions, and expenses can accomplish the same result by establishing a donor-advised fund with the community foundation. Using a donor-advised fund within a community foundation also offers a donor more generous tax deductions than those offered to donors to a private foundation.

Whatever your charitable intentions, there are ways to achieve them through your gift to your community foundation. The community foundation is easy, convenient, and inexpensive.

# How to Include the Vermillion County Community Foundation in Your Will

How you include a charity in your will depends on what sort of gift you would like to make, and how you want to provide for your other beneficiaries. Take a look at the examples below.

### ) MAKE A SPECIFIC BEQUEST

This bequest is an exact description of a dollar amount or specific asset from your estate to go to a beneficiary. It is very important that specific bequests be exact – vagueness can lead to confusion. Keep in mind that specific bequests are usually the first to be paid out.

When Christine made her will, she left her collection of fine art to her niece and \$50,000 to the Community Foundation.

### MAKE A PERCENTAGE BEQUEST

This bequest designates a fraction of the available estate to a beneficiary. Many prefer this kind of bequest because the relative size of the bequest is tied to the value of the estate, and that treats all heirs equally.

When Aaron made his will, he left 25% of his estate to each of his twin sons (50%), 25% to his local city park, and 12.5% each to his church and the Community Foundation.

### MAKE A RESIDUAL BEQUEST

This bequest assigns all the property that remains after the payment of administration costs, taxes and expenses, and every other bequest has been satisfied. A simple way to describe the residue of an estate is that which is "left over." After you have made provisions for individuals with exact amounts, you can give whatever is left of your estate to a worthy charity such as the Community Foundation. This option assures that your heirs are taken care of first.

When Mike made his will, he left \$150,000 to each of his four children (\$600,000), \$50,000 to a good friend Tiffany, and whatever was left of his estate to the Community Foundation.

### MAKE A CONTINGENT BEQUEST

This bequest puts in place a "back-up" beneficiary an individual or organization who will receive the gift only under certain circumstances. This option assures that unintended persons do not receive a gift originally meant for someone else.

When Dorothy made her will, she left her entire estate to her husband, Paul. In the event he precedes her death, her estate will be divided between the Community Foundation and two other worthwhile charities.

# **NEW FUNDS**

The endowment funds listed below have recently been established by local organizations, businesses, and/ or caring citizens. Any individual, business, or organization can establish a fund and/or contribute to an existing fund at any time.

Donations made to these endowment funds are invested and a portion of the earnings is used to award grants to community organizations and/or to award scholarships to students for their post-high school education. Donations can be made in a variety of forms including gifts of cash, stock, real estate, life insurance, and charitable bequests.

Endowment funds can be established in honor or memory of loved ones for as little as \$1,000. Payouts ("distributions") from endowment funds begin when the fund has reached \$10,000 in cumulative donations and has been invested for one full calendar year.

Here is a listing of the most recent endowment funds established though the *Vermillion County Community Foundation*.



### CAMERON CHEUVRONT MEMORIAL SCHOLARSHIP FUND

The family of late Cameron Cheuvront has established the Cameron Cheuvront Memorial Scholarship Fund to benefit area seniors from North Vermillion High School, Westville High School, or other senior students who attend a Wabash River Conference high school. Cameron passed away on May 11, 2022, at the age of 16, due to injuries sustained from an auto accident.

At the time of his passing, Cameron was a Sophomore at North Vermillion High School and playing baseball. He loved many sports and participated in basketball and wrestling as well. Cameron also loved to be outside whether it be working with his best friend in the business they had started, riding his dirt bike, fishing, or just playing with animals. Cameron was a member of the Cornerstone Christian

Church in Danville, Illinois and he was also active in his schools FFA chapter. Cameron was always smiling and cracking jokes, he was a very friendly kid with a heart of gold and always had a hug for anyone he met! Cameron made everyone he met feel like they were his best friend.

The applicant(s) for the scholarship must be accepted as a part- or full- time (minimum of 6 hours) student at a two-year or four-year public or private college or university. **Students pursuing a field of study or career in the trades and technical career pathway are strongly encouraged to apply.** 

Trade schools come in a wide variety of forms - some may be a part of an associate degree program, and some are totally autonomous. A major thought behind the scholarship is that trade schools and technical education programs provide specialized education for trade-based careers that focus specifically on job-related skills and does not typically require an advanced degree (bachelor's and/or master's degree).

Trade and technical education career pathways may include such fields of study such as; machining, dental, electrical, welding, medical, aviation, plumbing, robotics, construction, and the like. This is not an exhaustive list; but rather a listing to highlight the broad scope of the scholarship.

A variety of criteria will be used to determine the recipients. Some of the selection factors include financial need, school and/or work activities, community volunteer service and letters of reference.

The first scholarships will be awarded in the Spring of 2023.

### WILLIAM, JOHANNA AND MARK WILSON FAMILY SCHOLARSHIP FUND

The Vermillion County Community Foundation is pleased to announce the establishment of the William, Johanna and Mark Wilson Family Scholarship Fund at the Community Foundation.

According to Mark Wilson, the son of the late William and Johanna Wilson, "My parents were strong supporters of a variety of organizations, activities, and students in the Vermillion County area and they instilled these values in me. That's the reason I am so involved in organizations like the Community Foundation, Riley's Children's Hospital, Optimist International and others. It's a pleasure for me to give back to Vermillion County in memory of my parents.

In addition, I had the pleasure of being raised in Clinton and attended Clinton area schools for my first eleven years; then I was a graduate of the first class from North Vermillion High School, therefore both South Vermillion and North Vermillion High Schools are important to me. I attended Indiana State University and Danville Area Community College. I majored in accounting and minored in business and economics."

Any South Vermillion or North Vermillion High School senior is eligible to apply for the scholarship. The applicant(s) must be accepted as a full- time (minimum of 12 hours) student at a two-year or four-year public or private college or university or vocational trade school, with preference to an institution located in Indiana.

The scholarship is **renewable**; however, recipients must maintain a cumulative GPA of 3.0 and provide the community foundation with supporting documentation each semester (transcripts and proof of enrollment - a tuition invoice or similar). In the first year of the scholarship program the initial two recipients will be named. In four years, eight recipients will be receiving awards through the William, Johanna & Mario Wilson Family Scholarship Fund.

Several criteria are to be taking into consideration when selecting recipients. Some of the factors include; financial need, school and/or work activities, community volunteer service, letters of reference, and academics.

# TAX-WISE TIPS FOR YEAR-END GIVING

Year-end planning is a ritual for many of our friends who like to coordinate their tax and gift planning. However, it may take on additional significance as we adjust to the changing tax laws and marketplace. Individuals who want to make a difference for future generations should consider how they could increase the impact of their giving. Here are a few tax-wise tips that may be helpful for your year-end gift planning.

*Gifts by Check or Credit Card.* When you write a check to charity, the gift is complete when the check is mailed. Mail it by December 31, and you can deduct it for the year 2022 even if the charity does not cash it until 2023. When you charge your gift to a bank credit card, it is deductible by the donor in the year the charge is made.

*Gifts of Stock*. If your financial services provider holds the securities (including mutual funds) for your account, instruct that they be transferred electronically. We will provide you and/or your provider all the information needed. This is the most convenient way to make a gift. If you hold the stock certificate, give us a call and we can walk you through the transfer/donation process.

*Gifts of Appreciated Property.* Gifts of appreciated property that would result in long-term capital gain if sold generally produce even greater benefits for you than gifts made in cash, by check, or by credit card. The reason? You can generally deduct the full value of the contributed property (subject to the 30% of AGI limitation), even the gain portion that has never been taxed. Gift assets to consider include not only stocks, but bonds, mutual funds, real estate, and other appreciated property.

*IRA Rollover Gifts.* New legislation allows people age 70½ or older to withdraw up to \$100,000 annually from their individual retirement accounts tax-free if they give money directly to charity. Previously, withdrawals from individual retirement were subject to income tax and early withdrawal penalties.

Year-end is indeed a special time to give. Through creative gift planning, you may very well be able to do more for yourself and for the causes that are important to you.
